## IN THE NEWS...



**Conservatives continue legislative attack to curtail organizing rights** A Conservative backbencher has [tabled](#) Bill C-525, which attempts to curtail the ability of workers to organize and establish a union. The bill would make secret ballots mandatory, which will encourage intimidation and unfair practices by some employers. The bill also imposes what NDP MP Alexandre Boulerice calls "a form of vote rigging" in union certification votes, by counting everyone who didn't vote as being opposed to the union. The reverse would also be true in disaffiliations – those who don't vote will count as voting to decertify the union.

**Harper slips attack on workers' rights into latest budget** PSAC [criticized](#) the Harper government's budget bill for stripping the democratic rights of federal public sector employees and undermining health and safety protections in the Canadian Labour Code. PSAC says that the suite of changes set labour standards back by thirty years. To deny strike rights, Tories could arbitrarily determine what public servants are "essential." Public sector workers will no longer be able to decide voluntarily to go to arbitration for their agreements. Arbitration boards will no longer be independent. The bill changes the definition of "danger" in reference to dangerous work, to include only "imminent" risks, which PSAC calls a "life-threatening change" that will make it difficult for workers under federal jurisdiction to refuse dangerous work.

## Report from the 2013 Annual General Meeting of the Municipal Pension Plan

The theme for this year's AGM was "Taking the Long View". In attendance were current and retired members, and HR personal.

The Municipal Pension Plan (MPP) is the sixth largest Pension Plan in Canada with assets of \$28 Billion. Last year, the Pension Corp paid out \$91 million to 7,100 members. Twenty-five percent of pensions to retirees come from employers and members with the other 75% coming from investments. In 2012, the rate of return was 10.3% against a benchmark of 8.2%, proving to be a good year for investments compared to the fallout of 2008.

July 1, 2013 will see both contributions from both members and employers increase by 0.7% for a total 1.4% increase. Factors leading to the increase include the plan not meeting the 6.75% annual benchmark, lack of real salary growth and people living longer. The oldest retiree is 111 -- a retired nurse who has been drawing a pension since 1967.

The long view is promising for the MPP and its members. One out of every seventeen British Columbians and one out of every eleven adult workers are members of the plan. Remember your wages are deferred wages. The MPP is a defined benefit plan that pays for life. The board of trustees consider annually if a cost of living adjustment is required.

I would encourage you to visit the pension corporation website or call them in person. There is a great report on the Economic Impact of Public Sector Pension Plans from the Conference Board of Canada on the MPP website [mpp.pensionsbc.ca](http://mpp.pensionsbc.ca)

Our pension plans are not "gold plated" as reported over and over again by the Canadian Tax Payers Federation the Fraser Institute and the Canadian Federation of Independent Businesses. Your Pension is one of the pillars that provide dignity and respect in our third phase of life, retirement...
