

Presentation from Laura Shanner from United Way:

The United Way has a project that attempts to help end homelessness, with addressing certain needs and issues. There are programs all over with specialized skills to deal with a vast majority of things that people face on a regular basis, including bullying, and harassment, as well as programs that are preventative in nature, and teach life skills such as cooking.

Three sources: Charity Intelligence, Money Sense Canada, Imagine Canada, are good sources to go for information on charities; Laura advised that in a good charity, about 20% going to admin. The United Way in Central & North Vancouver Island was just over 11%, and the financial statements can be found online.

CUPE BC Report: Trevor Davies; Karen Ranalletta, Michelle Waite, Michelle Alexander

Trevor began by thanking the VIDC for the invitation to attend the meeting today; thanks for the donations to the wildfire fund. Money was also received from National. CUPE BC raised almost \$50,000 from a wide variety of organizations and individuals, including some individuals from Ontario.

Trevor wants to ensure that members remember to deduct the ferry mileage when sitting on the ferry as google maps includes this in its distance calculations.

Trevor reported on the following items:

- that the office move taking up a considerable amount of time, with more delays and an overwhelming number of decisions. Rent will be going up with the new building and there will be challenges with that
- CUPE BC has been trying to modernize so is undergoing some of the biggest internal changes that have been in a long time, and would appreciate as much notice as possible for any requests
- Discussion regarding the human rights commission
- Two large surveys precarious workers survey for community social services, K-12 custodian survey
- Policy review being led by Michelle Waite. The policy binder is a mixture of policies, passed resolutions, contradictory resolutions and the goal is to make this something that locals and councils could use, as well as being able to refer to them when resolutions are in the works
- There is a historical records project that came about from the volumes of files, tapes, videos, old reports, and daily journals in the dungeons of the CUPE BC office that need to be dealt with for the move. They are being donated to the Simon Fraser University's special archives collection to be used for research
- Pacific Blue Cross campaign the current board was in strong support of the employer's
 proposals and lockout of the members. They'd hired a CEO with a history of P3's who
 has now "retired" so CUPE BC has proposed a slate of labour friendly candidates, and
 is working with affiliates to get 1000 people in the room for the Dec 13 meeting at the
 Bayshore Hotel. PBC was created as a not for profit group in BC to provide benefits at a
 low cost and money to be put back into communities and it needs to stay/return to that.

Karen Ranalletta expanded a bit on the historical records project and advised that there are resources for locals to use who would like to take on a Local History project, including union made bronze plaques to recognize workers contributions to BC's success, BC Heritage Labour Centre, commissioning a bronze plaque local will have to contribute 1/3 of the cost. Oral history interview workshops. There is money out there to digitize records of locals, and are working on a tool kit to be able to preserve local's own history. As Part of affiliation to the BC Fed, locals can participate in the Missing and Murdered Indigenous Women's project.



<u>Ironworkers Local 97 joins CLAC</u>

The following statement was released on IBEW 213's facebook page on Monday September the 11th;

"Greetings:

Please be advised that it has recently been brought to my attention that Local 97 of the International Association of Bridge, Structural, Ornamental and Reinforcing Ironworkers (IW) in British Columbia have entered into an agreement with the Christian Labour Association of Canada (CLAC). Immediately upon becoming aware of this troubling situation I contacted the Canadian Director of the Building Trades Bob Blakely and have learned that a conference call has been scheduled with the Canadian Executive Board of the Building Trades, of which I am a member to discuss necessary steps moving forward. The British Columbia Building Trades held an emergency meeting yesterday, September 6, 2017, and have voted to censure Local 97. I will keep you apprised of any developments in this situation as I become aware of them.

Business Arising:

We reviewed our terms of reference adding a minor change to include "other trade groups"

Our action plan discussions lead to creating a "How to Apprenticeship Guide" to help locals set up apprenticeships to be completed by April 2018. We would also like put together a comprehensive package on the apprenticeship collective language to send to all CUPE locals. Local 1767 Report to the VIDC

December 2, 2017

I bring greetings and solidarity from our new President Jared Melvin. At our AGM in October I stepped down from that role after 12 years to create space for others to grow and to allow myself more time to pursue other opportunities with CUPE National.

Jared was our Vice-President for a number of years and prior to that our Regional Director for South Vancouver Island. Being located in Victoria and working at our Head office he has close access to the highest levels of managers in our company and wields broad influence in his role.

He is a committed social activist and has recently been working with our new Vice-President Harp Sandhu from our Vancouver office and BCGEU Treasurer Paul Finch to try to create solutions for the housing and rent affordability crisis affecting the Lower Mainland and other parts of our province. The plan can be found here: https://www.affordablebc.ca/our-plan.

Harp Sandhu had been our Regional Director for the North Lower Mainland and is also serving as a Trustee for the Public Service Pension Plan. Recently Harp worked on Jagmeet Singh's nomination campaign and continues to be influential in both federal and provincial NDP circles.

I remain on Local 1767's executive for one year as "Past President" in a mentoring capacity to ensure a smooth transition for all the issues and grievances that I had been involved in. I had been offered CUPE National work in November and December after having worked in Burnaby, Abbotsford and Kelowna earlier but this current leave request was denied by BC Assessment citing "operational requirements".

This is an issue throughout our company as we continue to struggle with an employer who fails to backfill for vacant senior level positions only to use those wages to create a slush fund and to hire short term temporary precarious positions. With our funding being largely by direct levy, it has been kept at well below inflation throughout the entire Liberal regime and both Jared and Harp are attempting to reverse that situation with the new NDP government with the proviso that any levy increase should be primarily directed to employees in the form of wages, benefits and the creation of full time permanent positions.

One active area of grievances we struggle with our Employer around is regarding employee wellness, benefits while on sick leave and medical accommodations in the work place. As an example, we recently had a co-worker want to come back to work after a lengthy period of time on long term disability. Their doctor had given the medical clearance required but since the specific position had been posted and filled years ago, the Employer claimed that there was no role for the individual to return to.

After a lengthy period of discussion, they offered a temporary, lower paid position that required a 1.5 hour commute. Our Collective Agreement allows for telework and alternate workplace





agreements and our work is easily done from almost any of our offices in the province. More recently they decided to allow the worker to work in their home office but we will still have to grieve for the member to be reinstated to a permanent position and with their previous wages and benefits.

From all of us in 1767 we wish you a peaceful holiday season!

Report on current substantial issues, accomplishments, trends at your local or workplace, bargaining issues, etc. Indicate how your local was affected, with specific details about how problems/grievances were resolved, and key information that might be valuable to other locals. Like many K-12 locals, CUPE476 has had a rough startup and fall. The members have seen increased workloads with only the bland explanation of [this is a result of the BCTF restored contract] as the reason behind it all.

The Education Assistants (HCA/SSA/EA) are the ones who have most obviously affected with additional late layoffs in August and over 10 rounds of postings to date. The School District has had little communication with CUPE476, even though we went to them at the beginning of September, when posting errors for EA's first appeared. At that time, we assured them that we were willing to work through the process with them to keep disruption to a minimum etc. At the end of October, we formally objected to the process and added job description language appearing in postings and then a meeting was arranged. Again, CUPE476 shared the concerns of the membership, particularly the EA's and how the lack of communication and cooperation between the SD and CUPE had caused us and our members hardship. Yet to date, little has improved.

In November we hosted "Coffeehouse Conversations" with the custodial departments. We met first with the Highschool group, as their work scenario is different to the other sites. Then a few of the custodians from both Elementary and the Education Center attended. It was a great opportunity to share the results of CUPE BC's Custodian Survey, talk about the why or why not some custodians didn't complete the survey (lack of privacy/ sealed envelopes/ unaware there was an online version/ lack of understanding the purpose & Use/negative comments by others upon receipt or distribution). Our Custodians welcomed the insight and were able to provide us with much needed information for future bargaining concerns, immediate issues regarding changing of posting locations, that had not been brought to the union, along with concerns over the growing number of outside users and the impact of partial coverage during absences on those users as well as workload, staff understanding of what partial coverage actually means and how many days that is happening on.

We hope to be able to host other such meetings with each department to better support the membership, express to them the rights they have and to gather information for future bargaining.

It is important to note at this time that CUPE 476 President, Daphne Ross is expecting to retire at the end of the 2017-2018 school year. Daphne has worked for SD47 for over 35 years. Her strength of character and knowledge has been our backbone for over 25 years. We offer our heartfelt thanks knowing that it is far from enough to cover all that she has done to serve CUPE476, CUPE BC and keep the union mandate alive.

VIDC Report – CUPE 1858

Dec, 2, 2017

- Two complaints have been filed against VIU at the BC Human Rights Tribunal by the former Director of the VIU Human Rights & Respectful Workplace Office. The complaints are regarding how the institution handled employee safety around an investigation into an alleged sexual predator at VIU. The union has members who may be called as witnesses in these complaints if they are accepted by the Tribunal. The Local is working with CUPE legal to determine whether we will apply for intervenor status in one of the two complaints.
- There was a serious accident with a student in our welding shop. Faculty and staff responded instantly and prevented a tragedy; however, there were issues with VIU's response to this accident. None of the unions were notified of the accident, nor were the members of our Joint Occupational Health & Safety Committee. Further, the investigation by VIU's Health & Safety Department was inadequate and, as of the last JOHS Committee meeting, none of the incident reports submitted to WorkSafe BC noted that a CUPE Tool Crib Attendant was in attendance at the event, rendered first aid and was, in fact, injured in the performance of his duties. VIU's Safety Officer was unaware of the injuries to our member. Also, while counsellors were provided to the students immediately, there was no critical incident stress counselling provided to employees until 3 days after the accident. All three unions at VIU have brought these issues forward to the employer and we're working with VIU to ensure they don't occur again.
- The Local is having a disagreement with the employer about a requested Labour Market Adjustment that would move a properly evaluated position under our job evaluation system significantly outside the wage grid. The Local feels that this does not take into account the other positions within our unit that are having recruitment and retention issues and that don't meet the wage level in the market. The Local is also concerned that this is a pay equity issue because the position with the requested adjustment is in a male dominated field while other female dominated positions are being ignored.
- Starbucks has now opened at the Nanaimo campus of VIU all staff are members of our Local. The opening of this location has allowed many of our casual Food Service workers to obtain less precarious employment at the university.
- The Local looks forward to welcoming VIDC to the Nanaimo campus in June for the VIDC 2018 Leadership Conference.
