

Our Negotiating Committee is pleased to report that we met with the University's Bargaining Committee for the third time on Tuesday, November 15, 2022. We are excited to announce that we had discussions on Truth and Reconciliation; as both committees have mutual interest. Our next date set to meet with the employer will be Thursday, December 8, 2022.

Hello from snowy Comox! It's too bad I couldn't attend this meeting in person due to a conflict with my own Local's executive meeting.

I was happy to attend the recent OBCM and the CUPE BC Environment Committee worked on reviewing convention resolutions that didn't hit the floor and discussed priorities.

Of many discussions we talked about the intersection between our pension plan investment strategies and our goal of stopping climate change. When I spoke with the CUPE BC Pension Committee that day I was reassured that they share the same concerns and are actively working on ways to influence those hired to invest our pension funds so that decisions made are good not just for returns, but also for the planet.

We touched on the Green Economy Network, of which CUPE is a partner. Their website is located here: https://greeneconomynet.ca/

They are a coalition of labour, environmental and social justice organizations and state three 'pillars' of focus:

Clean, Safe Transportation

Create a comprehensive plan to address the current needs of public transit across the country and develop high-speed rail between the nation's urban centres.

Clean, Renewable Energy

Develop a renewable energy strategy focussed on wind, solar, geothermal, and tidal power in the public sector.

Greener Buildings

Retrofit Canadian homes and buildings with green technology, improve energy efficiency and cut greenhouse gas emissions.

With regards to greener buildings we also talked about a small but growing trend to "de-construction". Rather than bringing in a bulldozer, tearing down an old house and taking all the material to a land-fill, some companies de-construct the home, and re-use, sell or recycle the material, resulting in a lot less waste. There is a higher cost of course, but a huge benefit to the environment.

A number of years ago, prior to a reno and addition on my home, I deconstructed my two carports and donated the 2x12's etc to Habitat for Humanity. The brick pillars and planter were deconstructed and re-used as facing of the new covered porch. The



original aluminum siding was taken off and sold at a scrap metal dealer and the Styrofoam siding backing was all recycled. Did it take me a lot more time and energy...YES, but it was well worth the peace of mind...plus it was a great weight loss program ©

Amber (the CUPE BC Environment Committee Chair) and I have been discussing the concept of swap sheds, which used to be at many landfills. The committee will be investigation their history and how they might be resurrected, hopefully with assistance from the municipal worker committee.

While they are no longer accepting written submissions from the general public, they continue to engage with Indigenous groups, the provinces and territories. This is a small part of what can be found in their webpage:

Climate change is happening now, changing our communities and our economy. It has prompted a global economic shift. Canada's future success hinges on our ability to compete in an increasingly green, low-carbon global economy. We want to work with partners to ensure that the transition to a net-zero economy is done in a way that creates new opportunities for Canadian workers and their communities — providing sustainable jobs for Canadians in every region.

The Canadians who built our current energy systems have the know-how and innovative ideas to create a prosperous, low-carbon future.

I was able to attend the OBCM meeting in Vancouver though I was only able to get to the tail end of the Pension committee since CUPE BC scheduled both committees that I'm a member of on the same day.

I attended the Environment Committee meeting to start with and was happy to report back to them the intersection of interests between the two committees... pension committee members and plan holders have a strong desire to have pensions investing in Green energies and divesting from fossil-fuel and other extractive industries.

Municipal Pension Plan Updates (MPP)

On the topic of Climate Change, the MPP posted a communiqué in November stating:

"Your plan is on the path toward net zero

In 2020, we made it a priority to address climate risk to the plan's investment portfolio. We committed to explore investing in a manner compatible with the Paris Agreement. We also wanted to understand the impact of a sudden and major policy change on plan investments. We have worked on this priority over the last two years.

The goal: Net zero by 2050"

Climate activists of course will say that this is much too slow. The pension plan goes on to state that its better to engage with the energy sector rather than divest, and note their fiduciary duty to obtain the best returns possible. Frankly that's inertia speaking... but perhaps I'm wearing the wrong committee hat at the moment!

Public Service Pension Plan Updates (PSPP)

If you are a member of this plan, this is their main page: https://pspp.pensionsbc.ca/

The 2022 annual report is now available as of November. The plan reports that, as of March 31, 2022 the one year return was 7.7% compared to the benchmark of 3.5%. While that's good news I'm not expecting as positive news in the coming year, given global investment volatility. Still, the 10 year annualized rate of return was 9.5% compared to the 8.2% benchmark...so quite good over the longer timeframe.

Fairly recently industrial and residential real estate was fueling a significant amount of the return but with interest rising quickly, the residential market is softening.

Climate Change and Responsible Investing also feature prominently in the PSPP report. Rather than talking about 'engaging with the energy sector' as the MPP plan does, the PSPP report stresses capitalizing on investment opportunities "from the long-term transition to a low-carbon economy".

Recently, the BC Human Rights Tribunal Awarded \$150,000 compensation to a Black/Indigenous/PWD mother who's four children were taken away from her for three years by the Vancouver Aboriginal Child and Family Services Society based solely on stereotypes about her as an Indigenous mother with mental health issues.



The United Nations' theme for International Day of Persons with Disabilities 2022 is <u>"Transformative solutions for inclusive development: the role of innovation in fuelling an accessible and equitable world."</u> CUPE recognizes the important message behind this theme to promote inclusion, equality and accessibility for the disability community.

As workers and activists, we need to understand that not all disabilities are immediately noticeable – from mental illness to learning differences, diabetes, chronic pain, cognitive dysfunction and much more. CUPE strongly supports the agenda of the disability rights movement. This commitment on the part of our union is heightened given the disproportionate impacts of COVID-19 on some of our most vulnerable citizens.

Persons with disabilities are at greater risk of contracting COVID-19 and have a higher mortality rate than the rest of the population. New safety protocols have posed additional challenges and concerns for persons with disabilities, undermining their access to full participation in society. For persons with disabilities who have intersecting identities, such as women, Black, Indigenous, racialized and 2SLGBTQI+ people, the impacts are even worse. We encourage all union leaders to take action to advance disability rights in our workplaces.

What can you do?

- Use December 3rd to educate and advocate for disability justice at work, in your local and in your community.
- Bargain for <u>measures that support disability rights in your collective agreement</u>, including employment equity, duty to accommodate, short and long-term disability coverage and language on mental health, HIV/AIDS and episodic disabilities.
- Carry out accessibility audits to remove barriers in your workplace and union spaces. Get your employer to make this a regular practice.
- Ensure virtual meetings are accessible for everyone by being proactive and asking members about their needs and referring to CUPE's virtual meetings accessibility checklist.
- Become familiar with the CLC's publication, "Doing Things Differently: A Disability Rights At Work Handbook".
- Sign up for CUPE workshops on disability issues.
- Remove barriers and encourage members with disabilities to become involved in union leadership and activities.

December 1 - World Aids Day

December 1 is World AIDS Day, and the start of Indigenous AIDS Awareness Week in Canada. On this day, CUPE renews its commitment to breaking down barriers for people with AIDS and HIV.

December 3 - International Day of Persons with Disabilities

The United Nations established International Day of Persons with Disabilities. On this day we focus on the challenges and barriers that persons with disabilities experience – as well as their successes – in our workplaces, unions and communities.

December 6 - Canadian National Day of Remembrance and Action to End Violence Against Women

On December 6, we mark the anniversary of the 1989 École Polytechnique massacre, where 14 women were singled out and murdered in an attack motivated by the gunman's hatred of feminism and women. One of those women, Maryse Laganière, was a CUPE member who worked at the school.

December 10 - International Human Rights Day

Every year on December 10, people around the world stand up for equality, justice and human dignity by celebrating International Human Rights Day.



December 18 - International Migrants Day

On December 18, CUPE expresses solidarity with people around the world who have been forced to leave their homes in search of decent work, safety, security, and a life where basic human and labour rights are respected.

CUPE's National Women's Conference will take place from March 12-15, 2023, in Vancouver.

The Committee met informally through email and in-person conversations while we were filling the Purses of Hope last night. We have a rough outline of some of the things we want to do in the coming year.

Accessibility Audits: CUPE National PWD committee encouraging all locals, district councils and divisions to do accessibility audits on all the venues they use to ensure all members are able to participate fully in their union, with dignity. These accessibility audits should be done at least every two years and/or after any significant renovations have been done to the venue. The National committee is revising their audit form and incorporating ideas from the Rick Hansen Foundation into it. They want to keep the process as simple as possible so that complexity of the process doesn't become a barrier. Stay tuned to hear more about this.



VIDC Resolutions Committee - December 3, 2023

Resolutions must be received by CUPE BC by noon on February 27, 2023. The Resolutions Guide should be on the CUPE BC website and if it's not, it should be soon. Please have a read of it before you get started writing your resolutions!

If you want VIDC to submit your resolution, which could be your personal resolution, your local's resolution, or your VIDC Committee's resolution, if you want VIDC to submit it, then it needs to be submitted to the VIDC Resolutions committee by February 1, 2023 so that the committee has time to review it and tweak it if necessary before it is put in front of the delegates at the February VIDC meeting for approval.

The VIDC Committee doesn't decide whether or not the resolution should be submitted to CUPE BC, that is the job of the VIDC delegates. The committee simply ensures the format is correct. We can also help write a resolution if you submit to us what you want CUPE BC to do (CUPE BC WILL:) and why you want them to do it (Becauses).

Your locals are welcome to submit any of the resolutions that VIDC submits – just be aware, if you change any part of the VIDC resolution, it becomes a new resolution submitted by your local only. It's better for the resolution to show numerous submitters, rather than have several similar resolutions submitted individually. However, if your local feels strongly about needing to change the resolution, they can do so.

I encourage you to send resolutions or ideas for resolutions, if you don't have time to write the resolution yourself – we want to show CUPE BC that locals and district councils are still interested in submitting resolutions to inform CUPE BC on how we want to see them proceed in the coming years. This is our parliament and our opportunity to have our voices heard through our resolutions.
